- follow the sacramental life of the church and will maintain my membership in the Body of Christ - His Holy Church - through faithful participation in the Holy Communion of His Body and Blood
- faithfully abide by and follow the disciplines, authority and leadership of church government and law described in the official Bylaws of our Eastern Diocese of the Armenian Church of America
- pledge my love, offering my financial support as established by our local parish assemblies and leadership. And, for the greater mission of The Armenian Church, I will give of my time and talent by participating in the various programs and charitable acts of faith requested by our Diocesan Primate and Council, our Pastor and Parish Council.

CHURCH MEMBERSHIP

ALL PERSONS WHO HAVE BEEN BAPTIZED AND CHRISMATED IN THE ARMENIAN APOSTOLIC ORTHODOX CHURCH, WHO ACCEPT HER DOCTRINE, CANONS AND RITES, AND WHO FULFILL THEIR OBLIGATIONS TO THE CHURCH AND COMMUNITY SHALL BE MEMBERS IN GOOD STANDING OF THE PARISH CHURCH AND SHALL CONSTITUTE THE PARISH ASSEMBLY. – Article 5 of the Bylaws

PARISH MEMBERSHIP DUES

EVERY MEMBER OF THE PARISH, 18 YEARS OF AGE OR OVER, SHALL PAY TO HIS/HER CHURCH AN ANNUAL DUES, THE AMOUNT OF WHICH SHALL BE DETERMINED BY THE DIOCESAN ASSEMBLY. SUCH AMOUNT MAY BE INCREASED, BUT NOT DECREASED BY THE PARISH ASSEMBLY. - Article 6 of the Bylaws
